- All orders are FOB/FCA Zinpro warehouse locations.
- Freight arrangements and third-party freight billing can be arranged through our Customer Services department (800-445-6145).
- A minimum lead time of 5 to 7 business days is required for all orders.

**Payment Terms:** Net 30 days from date of invoice. One percent (1%) cash discount is allowed if payment is postmarked within 15 days following invoice date. Discounts are allowed only for accounts that are current with no outstanding balances due. All invoices not paid in 30 days will be subject to a finance charge of 1.5% per month or less, when designated by state regulations.

**Product Returns:** The customer is required to provide product type, quantity and lot numbers at the time they are requesting to return product. The lot date stamp must be within two years of the date of manufacture. Upon receipt and inspection by our warehouse/plant, a credit memo will be issued for the product based on the price at the time of purchase. Any returned product must be returned in clean, dry, resalable condition. Damaged product will not be accepted and should be disposed of per your local regulations. Partial bags or bags with moisture damage will not be accepted. The cost of freight handling will be the responsibility of the customer unless there is fault on the part of Zinpro Corporation. Zinpro encourages proper inventory rotation and ordering frequency to maintain product freshness.
